Resolution of the Eastern Navajo Health Board

To Support and Sponsor through the 501 C 3 Process the Development of the Crownpoint IHS Hospital Landscape and Community Gardens Project and to support proposals to state, federal, tribal and non-profit organizations for funding the project.

WHEREAS:

1. The Eastern Navajo Health Board ("ENHB" or "the Board") was established by Navajo Tribal Council Resolution, CMY-46-80, and is given the responsibilities of promoting the interest and welfare of the Navajo People regarding all health issues and health-related plans in the Crownpoint Service Unit ("Service Unit") of the Navajo Area Indian Health Service ("NAIHS"); and
2. Members of the Board represents 16 Navajo Nation chapters located within the boundaries of the Service Unit, and as such, are knowledgeable of the health concerns and needs of the communities and residents they represent; and
3. The Board's policy is to develop, implement and administer programs that promote wellness and address health concerns of communities in the Crownpoint Service Unit and throughout the southern portion of the Eastern Navajo Agency; and
4. The Health Board offers its sponsorship, pending the re-certification of the 501 C status, of the development of the Crownpoint IHS Hospital Landscape and Community Gardens Project.
5. The purpose of the Crownpoint Landscaping and Community Gardens Project is to improve the Crownpoint Hospital and to develop a community gardens in a manner appropriate for local environment and local socio-cultural needs and perspectives.
6. The Crownpoint Landscaping and Community Gardens Project provides practical alternatives for grounds improvement and development of community gardens by incorporating natural systems such as natural plants, indigenous trees, recycling water in a cost effective manner.

7. To establish the Crownpoint Landscape and Community Gardens, the Eastern Navajo Health Board supports development of proposals for state, federal, tribal and non-profit organizations for project funding.

NOW THEREFORE BE IT RESOLVED THAT:

The Eastern Navajo Health Board

1. Supports the development of the Crownpoint Landscape and Community Gardens and further endorses the submission of proposals to granting agencies for funding the project.
